7. Standing Committee Reports

GSR Committee, Ayre, Chair

Ayre read highlights, see separate report

It was asked if is this a Free Standing committee

Joan J replied technically GSR is an intermediary between ABA fellowship and General Service
Association, "conference approved" refers to other fellowships such as AA because ABA does
not have a conference (a conference is made up of Area Delegates from all over who meet
annually)

This led to discussion of how literature is approved.

Joan J said developed literature is taken to the Directors to be reviewed and approved.

This has not been happening and it should be addressed further at the Directors meeting.

Joan J discussed sobriety requirements: GSR 6 months sobriety, GSA 1 year sobriety,
Literature Chair 2 years sobriety

Ayre asked how the GSR was able to be dissolved in the past.

Joan J explained there is nothing in the bylaws about this as the bylaws were created in 2003
but ABA did not have GSR until 2008 and suggested we may want to add something on this to
the bylaws.

It was agreed that this should be further discussed at the Directors meeting.

Literature and Outreach Committee, Lou W Chair but not present

Amy G read highlights, see separate report

Joan J commented that the ABA Concepts were modeled after Alanon's Concepts with written
permission from Alanon prior to printing and care should be taken to avoid plagiarism or ask for
further written permissions when making changes noting that this will also apply when writing
the ABA meditation book.

Judy B said the quote at the bottom of Alanon Meditation book lists quotes by celebrities and
notarities and thought this might mean we would not need written permissions for our meditation
book.

Joan J responded that they are cited as coming from those people. If we went ahead and used
our 12 Concepts we would put them forth as our own so we would still need Alanon's
permission due to having partially borrowed from them.

David F asked about sobriety requirements for Board members and if this needs to be incorporated into the bylaws.

Joan J quoted from Bylaw #1 "an applicant who is also an ABA member must have one year ABA sobriety to become a member"

She also reminded that the Bylaws are a legal document, and as such, any changes must be submitted to the government as a "Special Resolution".

David proposed resolution for Bylaw #6, which states that the Board must have no less than 12 members and no more than 20, be changed to a minimum of 7 "persons" and a maximum of 13 "persons" because we have historically been unable to meet the minimum. He suggested an odd number as this could avoid ties when voting on decisions.

Joan J said that both Bylaw #6 and #7 would need changes to reflect this.

Motion to amend Bylaws #6 and #7 to reset minimum to 3 "persons" excluding the four Executive Positions and maximum 20 "persons" MSC Joan J/Shelby S

A vote was taken by Quorum (12 ABA members) and carried unanimously
